Legalization of documents to be accepted in the Peoples Republic of China - UK passport holder.

<u>Step 1 – Notarized by a British Notary Public</u>

Print clear copies of all required documents with Chinese characters displayed clearly (For passport copies - Just the clear color photo page of the passport is required)
Bind seal any multi page document together before notary witnessing i.e. Power of Attorney.

- Then get the copy of your passport and your signature, where required, witnessed by a notary recognized by the Foreign and Commonwealth Office.

"If you are going to use British documents overseas, for business or personal reasons, you will probably be asked to have your documents legalized before they can be accepted"

"You can send your documents to Legalisation Office **by post** or bring them to the **public counter** in Milton Keynes. Postal applications take approximately 4 weeks to process. The public counter offers a same day service."

Processing time & Fees (as of 19th December 19, 2007) -

The legalization fee is £23 pounds for each commercial document or document. Normal service takes 5 working days. Express service takes 2 working days. Express fee is £15 extra per document. Please pay in cash, postal order or company cheque (payee is the Chinese Embassy).
